## Investment Performance ~ Review by Frederick Miller

Financial Consultant, Frederick Miller, reviewed a Performance Analysis Summary, dated December 31, 2018. He reported the following:

- The contributions and withdrawals were almost equal
- Year-to-date, the Annualized Performance was 2.89%
- Year-to-date, the beginning Market Value was \$187,343.82 and ending Market Value was \$174.756.77
- The Portfolio consisted of:
  - 13.05% Cash & Cash Alternatives
  - 30.70% Fixed Income
  - 52.90% Equity
  - 2.71% Alternative Investments
  - 0.64% Non-Classified

Financial Consultant Miller stated that he had no recommendations for the Board at this time.

Treasurer McDonald stated that the City would continue to pay the contribution cost plus an additional \$12,000.00 per the OPEB Corrective Action Plan that the City Commission adopted at their November 1, 2018 meeting.

City Manager Leven reported that she and Treasurer McDonald submitted the OPEB Corrective Action Plan to the State and it was recently approved.

Treasurer McDonald added that the OPEB reporting was required every two years and was last completed in 2018 and therefore would be required again in 2020.
