A regular meeting of the Marine City Commission was held on Thursday, November 5, 2020 at 200 South Parker Street, Marine City, and was called to order by Mayor Vandebossche at 7:00 pm.

City Manager Leven explained that the agreement was simply an update due to the fact that the employees who had approved the agreement were no longer employed by the City.

Motion by Commissioner Bryson, seconded by Commissioner Merchant, to approve the updated Raymond James Agreement. All Ayes. Motion Carried.

### Preliminary Financial Statements

Motion by Commissioner Hendrick, seconded by Commissioner Merchant, to receive and file the Preliminary Financial Statements. All Ayes. Motion Carried.

## **PUBLIC HEARING – 209 West Boulevard**

Mayor Vandebossche announced the Public Hearing open at 7:38 pm for public comment on the abatement and demolition of 209 West Boulevard.

Corey and Brandy Jasper addressed the Board and identified themselves as the property owners of 209 West Boulevard. They stated that permits had been pulled to rebuild the home. They also said they had a structural engineer access the property on October 14, 2020 to get approval for the foundation. They explained that, due to miscommunication, the structural engineer's approval letter had not been forwarded to the Building Official. They stated that they would email the letter to the Building Official the following morning.

Mayor Vandebossche closed the Public Comment at 7:41 pm.

## **UNFINISHED BUSINESS**

### Hidden Harbor Site Condo

In a memorandum to the City Commission, City Manager Leven reported that Hidden Harbor Site Condo Project was remanded back by the City Commission on September 3, 2020 to the Planning Commission for further review of the impact on local roads from construction equipment traffic and, the impact of the project on local traffic itself.

The Planning Commission reviewed the criteria on October 12, 2020 and ultimately passed a motion to accept the data as presented. The motion requested that the City investigate whether they should require a bond from contractors and to omit the information related to the 9<sup>th</sup> Edition Institute of Transportation Engineers (ITE) Trip Generation Manual.

In addition, the project was found to be compliant with zoning and the Master Plan, and City Manager Leven recommended a \$90,000 (\$85,000 for road/\$5,000 for water) bond to cover any necessary road or water main repairs.

Developer Jay Folske answered public comments asking about the units and said there would be twenty-six 2-bedroom ranch style units with a full basement, two-car attached garage, and be privately owned with a condo association. He said the units could be rented for a limited amount of time (2 years out of 5 years).

Commissioner Hendrick commented that she was concerned about infrastructure issues with some of the streets and the King Road side.

Mayor Vandebossche asked what the chance was of coming to a resolution between the residents and the developer by opening up Metropolis.

Mr. Folske replied and said a temporary road, west from the condo site to King Road, down the easement, could be built to be used only by Hidden Harbor traffic. He said the road could then be restored after the project was completed, and said he was worried about the damage from others using the temporary road. He added that the cost of the temporary road would save him the headache of trying to make the residents at ease during the construction phase.

Mayor Vandebossche asked if there was a way to make a permanent road from the temporary road since the gravel, etc. was already down.

Commissioner Klaassen stated he would like a secondary exit to King Road for the safety of the condos and the residents.

Adam Young of Wade Trim said the data provided on traffic was based on surveys recorded for special land use types and, from the survey, they come up with average. He said the studies could include delivery trucks, buses, etc.

City Attorney Davis stated that he didn't have confirmation that the City owned the property.

Commissioner Hendrick recommended that the City Attorney get in touch with former City Attorney, George Joachim, because he had documentation on the ownership of the property due to a road proposed years ago.

Mayor Vandebossche commented that this was a much better way to do this than to try to get a compromise between two parties.

City Attorney Davis asked if a special assessment district was created for the road, were there enough participants to absorb the costs over a 10 or 20 year assessment period.

Mr. Folske replied that he was unsure; they looked into it previously and it didn't seem feasible.

City Manager Leven suggested getting updated numbers for the special assessment district, and said confirmation of ownership was needed, as well as if the road was feasible. She said it was going to cost money to have research done on that.

Motion by Commissioner Hendrick, seconded by Commissioner Klaassen, to table the agenda item until we can get all the information from the prior City Attorney, the ownership information, and the special assessment information. All Ayes. Motion Carried.

The Board asked that DPW Superintendent Itrich be present at the November 19, 2020 meeting to provide information to make the temporary road permanent.

Dangerous Building – 209 West Boulevard

Building Official Kallek reported that the house located at 209 West Boulevard burned down in January of this year and it was months before the City could determine who owned the property. Due to the condition of the home, it was put before the Dangerous Building Board who ordered the abatement and demolition of the building on August 12, 2020.

Building Official Kallek requested a structural analysis from an engineer and a black mold remediation report due to the home being exposed to the weather for over ten months. He also said the furnace and hot water heater were under water. He said the owners of the property have stated that they have a structural engineer's report but he has not seen one.

Mayor Vandebossche inquired what the property owners would like to do with the property and they answered they would like to restore it up to code.

Commissioner Klaassen explained that a report from a structural engineer was necessary to know if the foundation could be built on.

City Manager Leven suggested that the agenda item be tabled subject to receiving structural engineering report.

Building Official Kallek stated that the building needed to be tarped as soon as possible.

Commissioner Bryson requested hard dates when the property owners were going to start and when the building was going to be closed up.

Motion by Commissioner Hendrick, seconded by Commissioner Bryson, to table until the November 19, 2020 meeting for engineering report, review of report, and milestones for the property. All Ayes. Motion Carried.

#### Resolution No. 004-2020 Utility Bill Deferment

Resolution No. 004-2020 Utility Bill Deferment was initially approved on May 7, 2020 to provide for waiving of late fees on utility bills for the months of March, April, May, June, July, and August.

On August 20, 2020, the City Commission voted in favor of extending the resolution through the months of September, October, and November.

Motion by Mayor Vandebossche, seconded by Commissioner Merchant, to extend the resolution through the month of February, 2021. **Roll Call Vote.** Ayes: Bryson, Hendrick, Kellehan, Klaassen, Merchant, Vandebossche. Nays: None. Motion Carried.

### **NEW BUSINESS**

#### 300 Broadway Update

Judy White, President of Friends of City Hall, provided updates on the restoration of old City Hall and provided a copy of Preservation Investment & Local Economy Development for the building.

Mrs. White explained that three major fundraisers for 2020 were cancelled due to COVID-19 and said that grants were the major focus for fundraisers.

She provided information that the following had been completed:

- Installation of 80' of water line (4" for fire suppression system and 2" for domestic use)
- Installation of a complete HVAC system, donated by Ray Skotarczyk

She also stated that the following projects had been started, but, to date, were not complete:

- Fire doors for upstairs hose tower
- Repair of two sections of sidewalk where waterline was installed
- Electricity brought to historic lamp post

In addition, Mrs. White stated that an architect had been hired to draft construction drawings for an elevator, a men's restroom, and a women's restroom. She said grants were being applied for to cover the cost of the projects.

Several exterior items were provided by Mrs. White that she said fell on the City to maintain:

- Paint chipping on doors and windows
- Tuck pointing
- Bandstand (offered to write a grant to replace bandstand)

#### Liquor License – Local Government Approval

Motion by Commissioner Hendrick, seconded by Commissioner Klaassen, to approve the Local Government Approval for John Sapienza. All Ayes. Motion Carried.

#### Infrastructure Subcommittee

Motion by Commissioner Hendrick, seconded by Commissioner Klaassen, to reconstitute the Infrastructure Subcommittee with existing members. All Ayes. Motion Carried.

Mayor Vandebossche announced a vacancy on the City Commission and asked for interested candidates to submit an application and letters of interest to the City Clerk on or before November 18, 2020.

## **COMMISSIONER PRIVILEGE/LIAISON REPORTS**

Commissioner Merchant said that it had been an honor to serve the citizens of Marine City as a Commissioner. He said he saw Marine City as having a great history with a wonderful future. He said he hoped to see the City progress not in the way of being commercialized, but continuing with its hometown, boutique, cottage industry feel so it could continue to be the jewel of the Blue Water area.

Commissioner Klaassen thanked Commissioner Merchant for coming aboard and said interested candidates should apply for the Board vacancy.

Commissioner Kellehan added that it had been great working with Commissioner Merchant and Mayor Vandenbossche and said that the City needed people to apply for the City Commission and other Boards. Commissioner Kellehan commented on what a rough, stressful week it had been for everyone and said she was proud of Marine City and said they would get through this together.

Commissioner Hendrick thanked Mayor Vandenbossche and Commissioner Merchant for taking on their positions on the Board and said it was great working with them. She also said it was nice to see the support of those getting out to vote. She sent condolences to

former Police Chief Jack Kelly's family and announced the Lions' parking lot had been paved. She also complimented those involved in the election for a job well done.

Commissioner Bryson thanked Mayor Vandebossche and Commissioner Merchant and said they would be missed.

Mayor Vandebossche said it had been a pleasure being on the Board and said it was bittersweet to leave the job but said he thought he could do more as a County Commissioner and represent the City, but in a different way. He thanked Commissioner Merchant for serving and said he gave a different perspective to the Board and helped focus them. He also thanked Commissioner Hendrick and said even though they argued, they worked well together and they got a lot done. Mayor Vandebossche thanked his wife and said she put up with a lot of grief from him.

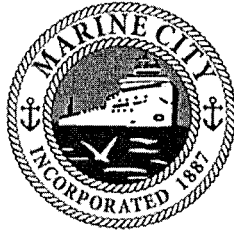

**City of Marine City  
Planning Commission Meeting  
October 12, 2020**

A regular meeting of the Marine City Planning Commission was held on Monday, October 12, 2020 in the Fire Hall, 200 South Parker Street, Marine City, Michigan, and was called to order by Chairperson Moran at 7:00 pm.

The Pledge of Allegiance was led by Chairperson Moran.

**Present:** Chairperson Joseph Moran; Commissioners Graham Allan, William Beutell, Madelyn McCarthy, Brian Ross, Keith Jenken; City Commissioner William Klaassen; City Manager Elaine Leven; Deputy Clerk Michele Goodrich

**Absent:** None.

### **Communications**

Motion by Commissioner Beutell, seconded by Commissioner McCarthy, to receive and file the Planning/Zoning Approval Process. All Ayes. Motion Carried.

### **Approve Agenda**

Chairperson Moran stated he would like to amend the order of the New Business Agenda items so that the Site Condo Plan: Degurse Avenue would be item 9A, and change Hidden Harbor Condominium Association – Traffic Review to item 9B.

Motion by Commissioner Ross, seconded by Commissioner Allan, to approve the agenda as amended. All Ayes. Motion Carried.

### **Public Comment**

Corey Waelens – 904 West Blvd. questioned what the intention of the Hidden Harbor Condominiums were and if they were going to be low income or standard units.

Dave Bannon – 6<sup>th</sup> St. stated that he had not seen anyone out conducting a traffic study, asked if there was going to be a special assessment on homeowners, and said that the City needed to figure out the traffic situation without destroying the roads.

Betty Babel – 162 N. 6<sup>th</sup> St. stated that she received no communication from the City regarding the Condominium development and that she was concerned about the safety of the residents and damage to the roads if the development goes forward.

Shelley Kargula – 117 N. 6<sup>th</sup> St. also stated that she received no communication from the City regarding the Condominium development and that she does not want the trucks to go up and down the street.

### **Approve Minutes**

Motion by Commissioner Beutell, seconded by Commissioner Allan, to approve the September 14, 2020 meeting minutes. All Ayes. Motion Carried.

### **Unfinished Business**

None.

### **New Business**

Chairperson Moran verified that all Board members received a copy of the Master Plan and that the Master Plan would be on the agenda for the next Planning Commission meeting.

### **Site Condo Plan: Degurse Avenue (Charles Beattie)**

John Monte with Project Control Engineering stated that he had received the recommendations from Wade Trim on the Preliminary Plan Review. Mr. Monte questioned if Adam Young with Wade Trim had received the correct plans as Mr. Young referenced both the Re-Zoning drawings and Preliminary Plans in his recommendations. Mr. Young was provided with a copy of the plans labeled Preliminary Construction, dated 08/12/2020.

Chairperson Moran confirmed that since the plans referenced individual home sites that there would be little to no need for internal sidewalks. Mr. Monte stated that Chairperson Moran was correct and that the sidewalks would be going along Degurse and Gladys.

Commissioner McCarthy questioned if the gap in the sidewalk that was referenced in the Planning Commission meeting minutes from March was addressed. Commissioner Beutell advised that the continuation of the sidewalk referenced a different project.

Commissioner McCarthy questioned if establishing an easement was a possibility in the event the City or Association were able to connect the bike path at a future date. Mr. Monte responded that he could speak to the property owner about an easement.

Chairperson Moran questioned if community drainage was allowed into the wetlands. DPW Supervisor, Mike Itrich, responded that to the best of his knowledge, it was.

Chairperson Moran stated that public sewage needed to be compliant.

Chairperson Moran questioned if the project addressed planting trees on the property side and Mr. Monte confirmed that this was what they had done. Commissioner McCarthy requested that the property owner consider an alternate tree variety other than a Maple which was being proposed. She stated that the property already had a lot of Maple trees and suggested planting a black gum tree for diversification. Mr. Monte responded that he could speak to the property owner about using a different tree species.

Motion by Commissioner Beutell, seconded by Commissioner McCarthy, to approve the preliminary Site Condo Plans: Degurse Avenue. All Ayes. Motion Carried.

### **Hidden Harbor Condominium Association – Traffic Review**

Chairperson Moran referenced the memorandum from City Manager Leven dated 10/01/2020 to the Planning Commission that advised them of the City Commission's motion to remand the project back to the Planning Commission for further review of the impact of the project on local roads from construction equipment traffic and the impact of the project on local traffic as a whole. Chairperson Moran requested that the aforementioned memorandum, the data provided by Wade Trim and the Planning Commission meeting minutes be provided to the City Commission and serve as the Planning Commission report.

Chairperson Moran read, for the record, the letter with the subject line: Traffic Route For Construction from DPW Supervisor Mike Itrich to City Manager Leven dated 10/06/2020. The letter provided information to help determine possible traffic routes for the construction traffic. Mr. Itrich's primary recommendation was to provide a temporary construction access route utilizing a private easement from King Road, or as an alternative from West Boulevard. He advised that if a temporary construction route was not feasible, there was a limitation on local roads that no truck with three or more axles utilize them unless it was a designated truck route and that there is no designated truck route to the site. Mr. Itrich's letter stated that if the developer was unable to meet this requirement, he would have to submit a request to the Chief of Police for a permit.

DPW Supervisor Itrich stated that the City has a 60 foot easement from Metropolis to King Road and on 7<sup>th</sup> Street the City has a 24 foot easement.

Commissioner McCarthy questioned if the developer would have to bring the route up to a standard to carry the weight of the construction traffic and if the City had a projected cost to do so. Mr. Itrich stated that the roads would need 8" of stone and he did not have a cost.

Commissioner Jenken questioned if the City required bonding from contractors to the City. City Manager Leven stated that she was not aware of any requirement in the ordinance. Commissioner Allan questioned if the Board could ask City Commission to consider bonding as a requirement. Commissioner Klaassen stated that he believed they could require a bond but needed to consult with the City Attorney. Commissioner Jenken advised that contractors would not need a bond if they used an alternate route for construction traffic.

DPW Supervisor Itrich stated that if the developer did not want to use the alternate route, then 6<sup>th</sup> Street would have to have temporary parking on one side however, the Chief of Police would be the one to make that decision.

Adam Young with Wade Trim introduced himself as the Planning Consultant for the City and advised that he was tasked with looking into the impact of the project on local traffic as a whole. He stated that he provided a memorandum to City Manager Leven on 10/06/2020 that addressed the Hidden Harbor Traffic Generation Data. Mr. Young advised that the information was not based on a traffic study where someone would have gone out and done traffic counts but rather, based on published standards outlined in the Institute of Transportation Engineers (ITE) Trip Generation Manual.

Mr. Young summarized the data presented in his memorandum and outlined the daily rate of trips for the proposed Hidden Harbor project both under the 9<sup>th</sup> Edition of the ITE Manual and the 10<sup>th</sup> Edition of the ITE Manual. Chairperson Moran requested that they focus solely on the 10<sup>th</sup> Edition of the ITE Manual and ignore the 9<sup>th</sup> Edition in an effort to eliminate confusion.

Mr. Young advised that per the City Commission request, he was to come up with assumptions on how cars will come in and out of the development; he advised that future residents of Hidden Harbor may utilize a combination of seven different streets. Chairperson Moran stated that according to the information presented, the current total traffic allocated across the local streets was 859 daily trips and with the addition of the



Hidden Harbor development it would increase to 1,010 – 1,049; an increase of approximately 22%.

Commissioner Klaassen stated that all of the streets have two outlets however, the Condominium development dead ends. He stated that if there was a fire, people would be trapped if they did not have two exits.

Chairperson Moran requested the Board to make a motion to accept the information as presented as fulfilling the request from the City Commission. Commissioner Allan requested the motion include the addendum that City Commission look into acquiring a bond. Furthermore, Commissioner Ross requested the motion omit the information associated with the 9<sup>th</sup> Edition ITE as recommended by Commissioner Moran.


Mr. McNamee, legal representation on behalf of Jay Folske, owner of the proposed Hidden Harbor Condominium development, requested to speak at this time. Chairperson Moran stated that there was a current motion on the floor and that Mr. McNamee could not address the Board.

Motion by Commissioner Allan seconded by Commissioner Beutell, to accept the data as presented, in addition to the Planning Commission minutes, as fulfilling the request of the City Commission. In addition, the Planning Commission requested that the City investigate whether the City should require a bond from contractors and to omit the information related to the 9<sup>th</sup> Edition Institute of Transportation Engineers (ITE) Trip Generation Manual. All Ayes. Motion Carried

### **Adjournment**

Motion by Commissioner Beutell, seconded by Commissioner Allan, to adjourn at 7:49 pm. All Ayes. Motion Carried.

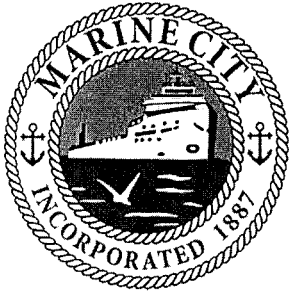

Parker to our City Hall and meeting space. The City of Marine purchased the building at 260 S. Parker to be converted to administrative offices, storage, and public meeting space. The building was originally a restaurant, and an addition was added to the back. The building most recently served as a fitness center and chiropractic office. The total space is about 6,500 square feet encompassing one floor with a mechanical room upstairs accessible from the exterior. Recent improvements include all new HVAC units and roofing. The building is currently vacant and scheduled to have the windows and siding replaced in the near future.

### SCOPE OF WORK

The City has construction plans and specifications and is ready to move forward with the construction phase. The scope of work involves the following trades:

The following goals were suggested as potential major goals by City Commissioners. Parentheses indicate the number of votes received for each item at the strategic planning meeting on March 4, 2019.

- Repair our roads (10) – *suggested by two Commissioners.*
- Repair our underground water and sewer system (7) – *suggested by two Commissioners.*
- Build/lease a new building for City Hall (7) – *suggested by six Commissioners.*
- Update water/sewer plants to ensure that they are in compliance with state regulations (4) – *suggested by three Commissioners.*
- Recreation programming/opportunities (3) – *suggested by four Commissioners.*
- Ensure Marine City has adequate financial resources to maintain and update needed equipment and infrastructure and to provide and maintain services for all stakeholders (2).
- Promote and support entrepreneurship in Marine City (1) – *suggested by two Commissioners.*
- Update sign ordinance to include allowance of easement signage during business hours (1)
- Improve the image of our Police Department (1).
- Bring in more manufacturing jobs – *suggested by two Commissioners.*
- Build dockage for large passenger ship and historic vessels on the St. Clair River – *suggested by two Commissioners.*
- Update city-wide monument signage at City entrances – *suggested by two Commissioners.*
- Encourage the development of the few sections of vacant land in the city to expand the city tax base.
- Start an Economic Development committee to plan for the future and keep businesses moving into Marine City. Work with the Chamber of Commerce to facilitate.
- Adopt a plan to address the issues with infrastructure and roads.
- Provide Wi-Fi throughout the city.
- Chamber of Commerce to report to City Commission monthly. Current Chamber is almost non-existent; visitors to Marine City need a visible place to go to get maps and city information. Staff Chamber with volunteers that welcome visitors and promote our city.
- Working with surrounding communities to cooperate on services and projects due to diminishing manpower.
- Re-evaluate DPW job functions.
- Re-evaluate sidewalk program.
- Raise the residential property values if possible, but at the very least stabilize them.
- Form a Beautification Committee (or a sub-committee with existing Garden Club, Civic Women's, Rotary) to help raise funds for all citywide holiday decorations, special markings (flags, etc.) to highlight the main City streets (Water, Broadway, Parker, and Chartier) and provide discounted sales to residents to purchase trees, shrubs, and flowers.
- Maintain and promote Marine City as a pleasant place to live, work, and visit through a proper and thoughtful arrangement of land uses within the city.
- Marketing or "branding" Marine City. Bringing on a consultant, someone with a design background, to help with this process. This would help encourage visitors.
- Continue blight enforcement efforts and hold landlords responsible for their properties.

## **LONG-TERM PLANNING CONSIDERATIONS FOR THE FUTURE**

The following items were identified by City Commissioners as being longer-term issues that would impact the City over the next five plus years:

- The impact of the Marine City/Sombra Ferry closure.
- Further exploring the feasibility of a public marina.
- Attracting and retaining talent.
- Increasing the City's tax base.
- Identifying potential brownfield redevelopment sites.
- Attracting high-tech manufacturing and research developments.
- Budgeting to address water/sewer line replacement.
- Exploring incentive programs for home buyers to purchase houses in Marine City.
- Planning for and providing services for an aging population.
- Identifying opportunities for regionalization and partnerships.
- Adapting to changes and decreases in funding resources.

## **MAJOR CITY ACCOMPLISHMENTS**

The following were identified as major City accomplishments during the past one to two years:

### **City Manager:**

- Combined and updated the City's master plan and five-year parks and recreation plan.
- Updated City ordinances.
- Investigated locations for City offices.
- Completed a downtown parking study.
- Implemented a sound system for City Commission meetings.
- Developed complete capital improvement plans.
- Rolled out a sidewalk improvement program.
- Increased the fund balance by \$500,000 over the past two years.
- Leased out the historic City Hall building (300 Broadway).
- Implemented recommendations from the Infrastructure Committee.

### **Police Department:**

- Maintained a functioning police department while staying under budget.
- Continued in-house training of police officers at minimal cost.
- Reviewed and updated General Orders.
- Reviewed and updated departmental forms.
- Met with MML (insurance) regarding future training.
- Successfully passed state audit regarding Law Enforcement Information Network (LEIN) services.
- Successfully passed Michigan Commission on Law Enforcement Standards (MCOLES) audit.
- Added a departmental K-9 program at minimal cost, including a donation from an insurance company for K-9 vests.

**Finance:**

- Changed job duties to comply with audit requirements of checks and balances and workload by employees, leading to increased efficiency.
- Implemented automated payments, including ACH withdrawals from customer accounts and payments to several accounts payable vendors.
- Assisted residents and the department with online payments by residents for water/sewer and tax bills.
- Continued to post all tax and water/sewer information online for residents to view and make payments.
- Started cross-training within the department.
- Updated fillable forms and made them available on the City website.

**Building:**

- Enhanced code enforcement efforts.
- Started a rental program and have had many new construction projects, both renovations and new construction, in the City.

## City of Marine City Request for Proposals

### COMPUTER NETWORK SUPPORT SERVICES

#### Introduction

The City of Marine City seeks proposals from qualified firms for Computer Network Support Service. The City has no IT professionals on staff. The vendor would coordinate work through a designated employee. It is the City's preference for the successful bidder to provide Computer Network Support remotely, and on-site only when deemed necessary.

#### Scope of Work

The City has a networked computer system between multiple municipal buildings with several interconnected servers. There are approximately two dozen desktop computers, several network printers and multifunction scanner/copiers. The system is Microsoft based and we utilize BS&A software for multiple applications. The scope of services of this RFP is as follows:

1. Network support services
2. Hardware/system software installation
3. Network maintenance
4. Operating system upgrades
5. VPN configuration/maintenance
6. Operations analysis
7. Design and analysis
8. Recovery planning
9. Backup planning
10. Performance tuning
11. Develop hardware inventory and replacement program
12. Remote management services
13. Network security management
14. Website management support

#### Proposal

Each proposal should be prepared simply and economically. **Ten copies** of the entire proposal must be submitted. Respondents must provide the following information in their proposal:

1. Letter of Transmittal — limited to two (2) pages in length, and should including a brief statement of the Respondent's understanding of the scope of work and identification of a single-point-of-contact whom will be the primary service provider to the City.

2. Executive Summary — Each Respondent shall submit a brief overview of the service provider and the personnel to be assigned to the proposed contract. The summary shall be limited to five (5) pages in length, and shall consist of no more than one (1) page for the service provider overview and four (4) pages for personnel to be assigned.
3. Respondent History — Respondents shall present information to demonstrate financial stability and performance, operational history, and service provider biography. Marketing materials are acceptable.
4. Respondent Identifying Information — Name and location of major offices and other facilities (other than the one identified on Proposal Form) that relate to respondent's performance under the terms of this RFP;
  - a) Name, business address, business and fax telephone numbers, and email address of the proposed principal contact person.
  - b) Information on service provider's experience, competence and reputation in providing similar services.
5. Respondent Qualifications — This section must contain all pertinent information relating to the Respondent's service provider and experience that would substantiate its qualifications and capabilities to perform the services requested. To include:
  - a) Statement relating to existing clients and whether current work presents a conflict of interest with potential contract with the City. Provide sufficient, non-confidential details for independent verification by the City. The City shall be the sole decision-maker about whether a conflict exists between its interests and those of a service provider's other clients.
  - b) A narrative description documenting the service provider's and personnel's experience.
6. Client References — Provide client references for similar service performed within the last three years. The list of clients must include the following:
  - a) Name and address of client
  - b) Name and phone number of client contact
  - c) Outcome of the contract, if completed and available for disclosure
7. Service Provider and Staffing Plan — Respondents shall submit information relating to their personnel that would be working with the City. Comparable resources must be guaranteed throughout the course of the relationship with the City.
  - a) The Respondent will provide qualifications of all staff and contractors, their role(s) on the contract and experience with related projects.
  - b) As applicable, all staff must be licensed to practice in Michigan and their licenses must be in good standing.
  - c) All staff assigned to the contract will have a background check done through the police department and must be reasonably acceptable to the City.

8. **Project Manager** — Respondents shall specifically identify the individual who will be responsible for management of this representation. The individual identified shall not be reassigned unless consented by the City. Provide a detailed resume for this person. Include the number of years of experience in providing similar services as those to be delivered to the City. The following information must also be provided for this individual:
  - a) Length of service with the service provider
  - b) Other relevant qualifications
  
9. **Compensation** — Complete the attached Price Sheet and provide a sample billing report to demonstrate how services rendered are recorded. Responses shall be in the same order as the requirements are listed to ensure the evaluator is able to easily locate the information requested.

### **Exceptions**

Respondent shall clearly identify any proposed deviations from the language in the Request for Proposals. Each exception must be clearly defined and referenced to the proper paragraph in this RFP. The exception shall include, at a minimum, the Respondent's proposed substitute language and opinion as to why the suggested substitution will provide equivalent or better service and performance. Proposals not meeting all requirements may be rejected. The City reserves the right to accept or to allow the Respondent to withdraw any or all exceptions.

### **RFP Modifications/Addenda**

Clarifications, modifications, or amendments may be made to this solicitation at the discretion of the City. Addenda may be issued no less than 10 days prior to the proposal deadline. Any and all Addenda issued by the City will be posted on our website at [www.cityofmarinecity.org](http://www.cityofmarinecity.org) under Public Notices. It is the responsibility of the Respondent to obtain the available Addenda and acknowledge any issued Addenda on the Proposal Form for this solicitation. ## CITY OF MARINE CITY MANAGERS REPORT

*Elaine Leven – November 12, 2020*

The attorney is working on gathering information regarding the previous plans to extend Metropolis to determine if it is still feasible to extend Metropolis to King Road. I am working with Joe Moran on a grant for the Kayak Launch.

### **Outstanding Items:**

- City Administration Office Space: Materials have been ordered for the exterior improvements. Availability for the siding is an issue that is on the agenda for consideration, as well as a proposed RFP for construction management.
- Ordinance Updates: The Planning Commission reviewed the Master Plan and it will be at the next meeting for City Commission review. Upon final approval of the minor updates to the master plan, they will address the ordinance updates.
- Redevelopment Ready Communities Program: The EDA is almost complete with their property brochures for submittal. The draft master plan has been submitted to the Planning Commission and will be on their next agenda for review.
- SEMCOG Water Feasibility Study: Wade Trim is completing the report and should have a final report to City Commission shortly.
- City Manager Evaluation: The first step to work towards an improved process for the City Manager evaluation is to review the City Commission 2019-2021 Goals and Priorities and update as necessary. This is on the agenda for discussion.
- Park Moratorium: We have discussed limiting the number of things in our parks to ensure ample greenspace. This stems from issues with approvals dating back years and the ability to keep track of them. In the future we should consider a plan or ordinance for how to deal with requests for items placed in City parks.
- LED Streetlight Conversion: Materials have been ordered and should be received in November. Upon receipt DTE should schedule the installation.
