# **Paving Bids Recommendation**

DPW Superintendent Itrich reported that three bids were received for the West Boulevard and North Belle River paving project. He advised that the bids were broken down into three sections and asked for approval for a portion, or a complete package, from one of the bidders:

- 1) West Boulevard from M-29 to South Belle River; the intersection of South Belle River at West Boulevard; the right lane of North Belle River to Fairbanks.
- 2) North Belle River from Fairbanks to the north curb line of Degurse.
- 3) North Belle River from the north curb line of Degurse to north city limits.

Motion by Mayor Vandenbossche, seconded by Commissioner Lepley, to contract with Jelsch Paving Company for the complete package of all three sections in the amount of \$245,775.15.

# Return Sludge Pump Recommendation

DPW Superintendent Itrich reported that the city had received its Michigan Department of Environmental Quality (MDEQ) Wastewater Construction permit to proceed with replacing the failed return screw pump at the Waste Water Treatment Plant. He reported that he and Tetra Tech representatives were recommending replacing it with two submersible sewage pumps from Kennedy Industries in the amount of \$26,500.00.

In addition, Mr. Itrich explained that Tetra Tech had requested bids for the electrical installation of the two submersible sewage pumps. He advised that three bids were received and recommended that the city contract with Sideline Electric in the amount of \$44,280.00.

Motion by Commissioner Hendrick, seconded by Commissioner Avery, to contract with Sideline Electric for the electrical portion of the project in the amount of \$44,280.00.

# Lighthouse Park Anchor

DPW Superintendent Itrich recommended two options for the placement of the anchor that is currently located in Lighthouse Park:

- 1) Pour a cement pad close to where the anchor is situated currently.
- 2) Place the anchor behind the Guy Center on the first cement pad to the north; the cement pad would have to be extended an additional five feet. A picnic table would be placed on the cement pad that is on the opposite side of the sidewalk.

# Water Street 15-Minute Parking Request from Paul's Bakery

In a memo to the City Commission, City Manager Leven reported that a request for a 15-minute parking spot in front of their store had been received from Paul's Bakery based on hardship for customers picking up large cakes.

Motion by Commissioner Klaassen, seconded by Commissioner Hendrick, to approve the request for a 15-minute parking spot in front of Paul's Bakery.

It was clarified that the parking space would not be limited to the bakery, but may be used for all businesses.

Police Chief James Heaslip explained that one of the Temporary Traffic Control Orders was for the upcoming Charity Poker Run and the remaining were for Maritime Days.

Commissioner Kellehan requested an additional Temporary Traffic Control Order for Broadway Street, between Main Street and Water Street, during the Maritime Days Parade. She said the parked cars created a safety issue during the parade.

#### **COMMISSIONER PRIVILEGE**

Commissioner Lepley asked that two women be remembered who had recently passed away – Ruth Balfour and Helma Tisdale. She reminded everyone to vote in the upcoming State Primary Election.

Commissioner Klaassen clarified that infrastructure money (from the millage proposal) would not be going to Water Street, but to the repair of other streets.

Commissioner Kellehan gave a shout out to Michael Itrich and the DPW crew for doing a fine job during the recent heatwave.

Commissioner Hendrick replied to Mr. Seigneurie's comments regarding TIFA and said that the TIFA Board failed to provide a plan, and said that City Attorney Davis did an

excellent job providing more detail than was even necessary. She thanked the police department for giving out ice cream coupons for bicycle safety, and announced the Old Newsboys Santa Summer Fest on July 28, 2018.

Mayor Vandenbossche explained that his comments to the Times Herald regarding the upcoming millage were cut short. He complimented the Infrastructure Committee on a great job, and said he was adverse to any tax increase. Instead, he said, the city should look into other funding options.
