### Library Sign Approval

City Manager Leven reported that the library was looking for permission from the City Commission to replace their old sign with a new one. She said that no public funds would be expended for the sign.

Jill Scheel, Marine City Library Advisory Board President, said the new sign would be funded by a memorial contribution and money earned from fundraisers by Friends of the Library. She advised that the electronic sign was the same size as the existing one and would be installed in the same location.

Commissioner Hendrick commented that she would rather have the sign moved from the DPW and see the money be utilized for reading machines and programs for the community.

Allison Arnold, Director of the St. Clair County Library system, informed the Board that the person who made the memorial contribution asked that the funds be used specifically for the benefit of the Marine City Library, and said the estate language requested a lasting donation of something that wouldn't get used up – something that residents would be able to point to and recognize. She said if materials or computer equipment were purchased, they would be owned by the library system, not the branch.

# Ordinance No. 2018-006 – Sidewalks, Outdoor Sales and Cafes (First Reading/Introduction)

- Adding language to address outdoor seating and/or flowers for businesses with no sales
- For café's, setting a definitive five feet minimum of unobstructed pedestrian access along sidewalks
